Area Planning

Operational Plan 2

The planning year for Operational Plan 2: 2024-26 is has now concluded and will be announced publicly in September 2024. The plan contains a number of short-term workstreams which typically complete within the lifespan of the plan, and a number of other longer-term projects, a small number of which have carried over from Operational Plan 1: 2022-2024.

Specialist Provision in Mainstream Schools

The Area Planning Local Groups will reconvene in September 2024 for a workshop to identify pressure areas for SEN placements across Northern Ireland and consider options for specialist provision classes for the various key stages and pathways.

Minister Announces School Uniform Policy Consultation

Education Minister, Paul Givan MLA has launched a public consultation seeking views on school uniform policy.

The consultation focuses on two key areas:

- a. introducing statutory guidance; and,
- b. introducing a cap on uniform costs.

The Department of Education currently has guidance in place which provides advice to schools on what they should consider when developing their uniform policies. While the existing guidance is detailed and advises on many elements of uniform policy, schools are not currently legally obliged to comply with it.

The Minister of Education plans to introduce statutory guidance so that all school governing bodies will be required to review their school uniform policy and ensure costs are manageable for parents/carers.

The consultation seeks views on what should be contained within any statutory guidance particularly around the cost and affordability of school uniforms, the use of branded items and single supplier arrangements. Views are also sought on the proposal to introduce cost control measures, such as a price cap.

The consultation will run from 20 June 2024 until 27 September 2024. Further detail and information on how to respond is available here.

Marie Curie - Schools Bereavement Programme



The GBA recently met with Joan McEwan, Associate Director of Policy and Public Affairs at Marie Curie, and Christine Irvine, Senior Policy Manager at Marie Curie, to discuss a new programme in Northern Ireland addressing the need for bereavement information and support for children and young people in educational settings.

Marie Curie's Programme has included piloting a full day interactive training with classroom teaching staff (including whole school training) and piloting of a Lesson Plan on Loss & Bereavement (targeted at post-primary students), including training with 23 voluntary grammar schools.

The teacher training was done in partnership with CRUSE and an independent child bereavement counsellor. Marie Curie has also commissioned a set of questions on attitudes to grief education and experience of bereavement support in schools in two surveys- Public Attitudes to Death and Dying and ARK Young Life and Times Survey. The range of findings from the programme and recommendation will be published in a report being launched in November 2024.

Northern Ireland Assembly Updates

NI Assembly Education Committee

The Education Committee met again with <u>Panel members</u> for the <u>Independent Review of Education</u> on two occasions this month with the 1st briefing focusing on a number of areas such as educational disadvantage, early years, and the qualifications system.


A second briefing was held this week in which MLAs scrutinised aspects of the review report in greater depth, including:

- Early intervention
- SEND transformation
- Education budget gap and pressures
- Capital budget
- Curriculum offering
- Innovative area planning solutions

Overall, Panel members stressed the significant overarching concerns regarding the budget situation and the clear need for reform and investment in NI's education system. The Education Committee plans to continue their engagement with the Panel and is urging the Minister to bring forward the Department's priority areas.

Shared Education News



PEACEPLUS Northern Ireland - Ireland

Co-funded by the





A cross border consortium led by the Education Authority has been awarded €34.5m (£29m) of PEACEPLUS funding to support shared learning in formal education settings across Northern Ireland and the border counties.

The Advancing Shared Partnerships through Inclusive Relationships in Education (ASPIRE) project will bring students from different cultural, religious, and socio-economic backgrounds together to learn, while also providing joint training schemes to upskill educators to better equip them to facilitate shared learning.

The project aims to engage 111,000 pupils and 1,761 educators over the next four and a half years. The programmes will be delivered at every level including pre-school, primary and post primary schools, primarily targeted at those with no or limited prior engagement in shared education.

SEND Transformation Update

As part of the wider <u>End to End review of SEND</u>, the EA is reforming its services for children and young people who are at Stage 2 of the SEND Code of Practice (before a statutory assessment may be required). This will be through the establishment of new local integrated SEND support teams which are designed to wrap services and support around the needs of the child or

young person and their school.

The EA is adopting a staged approach to the implementation of Local Integrated Teams from September 2024, with the Autumn term being used to improve readiness, and January 2025 for full implementation of the new model. The EA has produced a <u>short video</u> which provides more detail on the process.

Equality Commission NI - Employer Training Programme

The Equality Commission is now providing a number of free online employer training sessions, focusing on a number of important equality issues and will expand to cover additional topics over the coming months.

The webinars are based on Northern Ireland equality law and are therefore of relevance, primarily, to employers and service-providers who employ staff in Northern Ireland.
