### **NI Draft Programme for Government**

On 5th September 2024 the Northern Ireland Executive agreed a draft programme for government, 'Our Plan: Doing What Matters Most', outlining immediate priorities to be worked through this year and throughout the duration of the current Mandate (2022-27).

In the "Grow a Globally Competitive and Sustainable Economy" chapter, the programme raises a *thriving Further and Higher Education* sector and a commitment to *build on, and support, our established Higher Education campuses at QUB, UU Belfast and UU Coleraine* (p.19).

Another key area is the delivery of more affordable childcare, including the development of the Early Learning and Childcare Strategy, with an investment of up to £25million this year

(p.20).

Better support for children and young people with Special Educational Needs (SEN) is highlighted as an immediate priority (p.34), stating that over the last decade, the number of children identified with SEN has risen steadily to almost one in five pupils alongside an increasing level of expenditure on SEN provision, not always matched by a demonstrable improvement to the outcomes for children and young people with SEN and disabilities.

# **GBA Political Engagement Update - VAT on School Fees Legislation**

The GBA has raised significant concerns in relation to the UK Government's intention to introduce 20% VAT on education and boarding services from the 1st January 2025.

To date we have engaged with the NI Secretary of State, Chair of the Education Committee, NI Members of Parliament and BBC News to highlight the potential impact of the legislation on voluntary grammar schools in NI.

Speaking to <u>BBC news</u>, Stephen Moore, Principal of Friends' School Lisburn said:

"It's legislation that's not really intended to capture schools like prep schools in Northern Ireland which do receive funding from government and which are very much departments of local grammar schools.

It also could have an impact on the sustainability of prep schools here and that could also have a knock-on effect on the grammar schools of which they're an integral part."

The Education Minister, Paul Givan MLA told BBC News NI that schools in Northern Ireland could not be directly compared with many private schools in England, and the new UK-wide approach did not reflect how the Northern Ireland education system is funded.

Speaking at the Assembly last week, the Minister said:

"I am making representations to the Labour Government on the issue. I

am very concerned about the direction of travel. To date, our representations have not been received effectively by London, so I encourage all Members, where they can raise these issues, to join me in making the case for the schools that will be negatively affected by the change."

The GBA continues to engage on the matter and will keep you updated.

# Proposed Changes to Qualifications Performance Measures

The Department of Education is seeking the views of post-primary schools and special schools with post-primary age pupils on proposed changes to how qualifications are counted for system level performance measures.

The proposals are in relation to the following:

- 1. Level 2 qualifications graded as Pass or Fail.
- 2. Size equivalency of qualifications.
- 3. Capping of how qualifications are counted.



### Radon Levels and Employer Responsibilities

The GBA recently met with Inspectors from the Health and Safety Executive for Northern Ireland (HSENI) to discuss the implications of radon levels in schools, employer responsibilities, and support for schools.

Many parts of Northern Ireland have high radon levels - the map below indicates where levels are likely to be higher. The darker the colour on the radon map below the greater the probability of a high radon level in a building.



Under the Health and Safety at Work (NI) Order 1978, employers must, so far as reasonably practicable, ensure the health and safety of employees and others who have access to their work environment.

The Management of Health and Safety at Work (NI) Regulations 2000 require assessment of health and safety risks including radon. This can be achieved through interrogating the map by inputting your postcode at this link: <a href="https://www.ukradon.org/information/ukmaps">https://www.ukradon.org/information/ukmaps</a> - Radon gas measurements are required to complete the risk assessment for all properties within radon affected areas.

### **Education Committee**

Over the past few weeks, Education Committee MLAs have received briefings from the Northern Ireland Human Rights Commission, Department of Education, Education and Training Inspectorate, EA, and CCEA in relation to their mini-inquiry into Relationship and Sexuality Education (RSE) (see article above for more details on the inquiry).

At this week's Committee meeting, the Chairperson raised school governance and complaints procedures and the committee's intention to invite the Northern Ireland Public Services Ombudsman to an evidence session.

Next week the Committee will meet with the Children's Commissioner in relation to the RSE inquiry. Members are also scheduled to meet with DE to discuss the end-to-end review of SEN transformation and the EA to discuss the Landscape Review.
