# Supporting Voluntary Grammar Schools: GBA Hosts Health & Safety Information Session

The GBA has been engaging with the Health & Safety Executive NI (HSENI) to identify key health and safety matters in schools and to support schools with their responsibilities in this area.

As part of our ongoing engagement with HSENI we recently hosted an information session for our member schools to look at a range of health and safety areas in the context of voluntary grammar settings as employers of staff.

The session was delivered by HSENI Principal inspector, Kyle Carrick, and HSENI Inspector, Linda Murphy who provided attendees with an overview of the following areas:

- Health and safety legislation
- Reporting of incidents/injuries/accidents
- Asbestos management
- Slips, trips and falls
- Lifting/handling
- Vehicle movements
- Legionella
- Radon

The session was well attended with representation from 29 voluntary grammar schools - thank you to all who attended. We hope to run an extended session in the next academic year.

# **HSENI** Legionella Initiative

During 2025, HSENI will be conducting a series of inspections in relation to the management of legionella in hot and cold water systems. These inspections will take place in buildings that provide facilities for vulnerable populations and/or the general public, including schools.

As you will be aware, as employers of staff, the Board of Governors of a voluntary grammar school has a responsibility to ensure that any risk from Legionella is appropriately managed. This includes making sure the right precautions are put in place to reduce the risk of exposure to Legionella bacteria.

The initial phase of HSENI's initiative will assess the measures currently in place to comply with health and safety legislation and the Approved

Code of Practice and guidance, The Control of legionella bacteria in water systems (L8) via a questionnaire, which has been issued to a <u>sample</u> of schools.

The premises chosen reflect the risk presented by Legionella bacteria and the potential for exposure.

If your school has received a questionnaire we would encourage you to complete this and return to HSENI by 27th March 2025.

The second phase of this initiative will entail a series of focused inspections to selected premises, with the emphasis being on those premises where the risk is perceived to be high or where completed questionnaires have not been received.

# **Area Planning**

<u>Development Proposals: Pre-Publication Consultation and Statutory</u>

Objection Period

When a significant change to a school is proposed (including opening, closing, amalgamating), and significantly altering its size or character, publication of a Development Proposal is a statutory requirement.

The Development Proposal process is complex and involves a number of

phases which includes a pre-publication consultation and a statutory objection period, before a decision on the proposal is made.

The pre-publication consultation seeks the views of those most directly affected by the proposed changes at a local level. The Education Authority also conducts further consultation with schools that may be affected by the proposal.

Following the pre-publication consultation, proposals are published on the Department of Education website and subject to a two-month objection period prior to a decision being made.

# Student Mobility Across the Island of Ireland A Level Equivalencies

The GBA recently received correspondence from Professor Becky Whay, Interim Deputy President and Registrar at the University of Galway regarding equivalency of A Level qualifications across higher education institutions in the Republic of Ireland.

New equivalencies are now in place and A-level students no longer have to earn 4 top grade results to get maximum points in the Republic's third level entry system. Instead, A-level students can use their best 3 A-levels, along with a 4th A-level or an Extended Project or an AS subject.

This will mean that applicants can attain a score of 600 points with 3 A levels and 1 AS, and 625 points if one of the A-levels is Maths. NI students will also be considered for a place in a university in the Republic by applying with 2 A-levels and 1 or 2 AS levels.

We would like to thank GBA Executive Committee member, Dermot Mullan, for his engagement with the Universities Ireland Working Group to raise the issues around student mobility and drive forward this welcome change.

#### School Uniforms Bill Introduced

A new Bill to reduce the costs of school uniforms has been introduced in the Northern Ireland Assembly by Education Minister Paul Givan.

The Bill completed First Stage at the Assembly on 18 February 2025 and the Second Stage is scheduled for Monday 3rd March 2025 which will entail a full debate on the Bill's general principles.

The GBA has received this information and will provide further briefing to schools in due course.

# **NI Assembly Education Committee**

This week at the Assembly, Education Committee MLAs met with the Panel for Educational Underachievement to discuss their report "A Fair Start" and the progress of the recommendations contained within.

One of the key actions arising form the report "Promoting a whole community approach to education' with a 'place-based focus that delivers the greatest concentration of effort in those localities with the greatest concentration of educational underachievement" has provided impetus for the RAISE programme which aims to address this area.

MLA's also heard a briefing from University of Ulster researchers in relation to their <u>report on Classroom Assistants</u> which aimed to establish a profile of the Classroom Assistant post in mainstream and special schools in Northern Ireland, including Classroom Assistant perceptions of the role and the future of the role.
